Communication of total amount of voting rights
pursuant article 85-bis Issuers' Regulation

Cernusco Lombardone (LC), 25 June 2025 – Notice is hereby given that, as of today, as represented in the following table (i) the subscribed and paid in share capital of the company Technoprobe S.p.a. (the “**Company**”) is equal to Euro 6,532,608.70 and it is divided into no. 653,260,870 ordinary shares without a nominal value, of which no. 241,907,609 with one vote right per each and no. 411,353,261 with two vote rights per each since they have obtained the increase of the voting rights pursuant to art. 7 of the Statute; (ii) the total number of voting rights is equal to no. 1,064,614,131; and (iii) the Company holds 5.742.451 ordinary shares with suspended voting rights pursuant to Article 2357-ter(2) of the Italian Civil Code as treasury shares of the Company.

The Company notes that, compared to the information disclosed on June 9, 2025, regarding the total number of voting rights, and following the sale by shareholder T-PLUS S.P.A. of a total of 10,000,000 ordinary shares of the Company—without nominal value and with regular rights—completed on June 10, 2025, through an *accelerated bookbuilding* transaction, the total number of ordinary shares has increased, while the total number of voting rights exercisable at the shareholders' meeting and the total number of ordinary shares with enhanced voting rights has decreased.

The following table shows the figures for the shares representing the share capital of the issuer and the number of voting rights exercisable at the shareholders' meeting from 10 June 2025 compared with the previous situation.
